Lee McCormick, President with Community Development Associates said that the resolution being presented today for their consideration was related to a refinancing of the AmeriTex Pipe & Products, LLC Project for bonds that were issued in 2008 by the MEDC Board. The company is looking into refinancing the bond and lowering the interest rate for the purpose of financing a \$2 million 16,000 sq. ft. expansion to their existing facility in Seguin, Texas. The company has been very successful in spite

of the economic downturn we have suffered during the past years. The Guadalupe County Commissioners Court approved this project at a meeting and public hearing today with no comments made.
